## GARBAGE PICKUP (1 PICK-UP PER WEEK)

- 1. All residents are required to use City of Foley Garbage cans.
- 2. Must be out before 6am.
- 3. Leave 3 feet of air space on each side of the can.
- 4. Place can with handle towards house, arrow towards the street for automated pickup.
- 5. One pick-up per week.

## YARD DEBRIS PICKUP (1 PICK-UP PER WEEK):

1. Yard debris (limbs, leaves, grass clippings) should be placed three feet from the garbage can.

2. The limbs should be no longer than six (6) feet in length and no bigger than six (6) inches in diameter.

3. The sanitation department will pick up six (6) cubic yards of yard debris per week. Removal of piles larger than six (6) cubic yards per week will result in a charge of \$30 per four (4)-cubic-yard increments over the initial six (6) yards.

4. Yard debris does not include stumps.

## BULK ITEM PICKUP (1 PICK-UP PER WEEK)

1. Bulk item pickup is scheduled every Monday unless there is a holiday, at which point there will be a holiday schedule released.

2. Foley Sanitation requires that the items be placed on the road over the weekend or first thing on Monday morning.

3. Bulk items include appliances, furniture, things too large for the 96-gallon trash can, etc.

4. Do not place bulk items with garbage, recycling, limb, leaf, and/or yard debris.

5. Once the items are curbside, residents should call the sanitation department at 251-943-8897, either over the weekend or Monday morning before 9 a.m. to be added to the Monday bulk item pickup list.

#### HOUSEHOLD HAZARDOUS WASTE (City of Foley does not have a landfill).

Includes hazardous waste generated solely by a residential household including, but not limited to, tires, batteries, used oil, paints and paint thinners, antifreeze, fertilizers, pesticides, herbicides, and chemicals (do not place waste curbside). Baldwin County Magnolia Landfill (251) 972-6878 accepts household hazardous waste during operational hours for a minimal charge. Latex paint may be disposed with regular garbage if the liquid is allowed to evaporate or absorbed by adding cat litter.

## **RECYCLABLES (1 PICK-UP PER WEEK)**

**Includes:** Aluminum cans, plastic bottles such as milk and soda containers and bleach bottles, newspapers and magazines, shredded paper (must be contained in a plastic bag), aluminum cans, heavy cardboard broken down 2' x 2', cereal boxes, tin cans (must be rinsed out).

**Excludes:** Plastic bags from Wal-Mart or other stores, no boxes that have come in contact with food (pizza or fried chicken), oil containers, glass and Styrofoam.

#### **DEAD ANIMALS**

The sanitation department picks up dead animals within the city limits of Foley. For pickup, call 251-943-8897.
